It is my responsibility to



Plant your Future Chairman Jenny Henman is also President of this organisation and sits on the Board of Directors in this role.

As per the Plant your Future Trust Deed we continue to seek to achieve the following objectives:

"to promote sustainable development for the benefit of the public by:

- a) the preservation, conservation and the protection of the environment and the prudent use of resources;
- b) the relief of poverty and the improvement of the conditions of life in socially and economically disadvantaged communities;
- c) the promotion of sustainable means of achieving economic growth and regeneration.

Sustainable development means "development which meets the needs of the present without compromising the ability of future generations to meet their own needs"

Plant your Future is working to achieve its core object of the promotion of sustainable development as described in our Trust Deed through activities with a focus on the promotion of sustainable resource use with economically disadvantaged smallholder/subsistence level farmers in the Peruvian Amazon.

We work with smallholder farmers in the Peruvian Amazon to help provide support (technical, logistical, financial, strategic) for the restoration of deforested/degraded agricultural lands through the promotion of sustainable agriculture. Our model for sustainable agriculture focuses on “agroforestry” and is designed to improve subsistence farmer’s livelihoods through the sale of crops, native fruits, sustainably harvested timber, as well as sale of carbon offsets. This will help in the relief of poverty and the improvement of the conditions of life in socially and economically disadvantaged communities. Our model is also designed to promote a sustainable means of achieving economic growth and regeneration amongst smallholder farming families of the Peruvian Amazon through income diversification. Smallholder farmers in the Peruvian Amazon have been identified by national statistics in Peru to be a group who continue to suffer from high levels of poverty, and who, as a collective group, are the main driver of deforestation of the Amazon Rainforest in Peru. Plant your Future’s model is directed specifically at smallholder farmers as the principle beneficiary group. Given their part in deforestation through ‘slash-and burn agriculture’ our objective is to help them develop more sustainable resource use, and in so doing achieve the object of the preservation, conservation and the protection of the environment and the prudent use of resources.

Volunteers continue to make an important contribution to Plant your Future’s work. Volunteers have supported Plant your Future in its fundraising as well as with monitoring, legal and technical work.

Summary of the main achievements of the charity during the year

It has been a fantastic year for our new programme in Ucayali – where we are working in the community of Nueva Esperanza. This area has suffered extensive deforestation, which large expanses of abandoned, treeless degraded pastures. This year has seen the construction of a new nursery which allowed us to cultivate 14,000 saplings – a mixture of cocoa trees and native hardwoods. We've also been cultivating guaba trees, known for their nitrogen fixing properties, to inter-crop with the commercial species which will improve soil fertility.

It has been exciting to build our team in Ucayali – we've had a lead farmer running the day-to-day activities of the nursery, we've coordinated many capacity building events with the farmers. One particularly noteworthy and inspiring training event was a day-long outing for all the farmers visiting examples of mature agroforestry systems elsewhere in the region in collaboration with The Peru Cocoa Alliance.

Patricia Romero joined our Ucayali team in June 2018 as an Agroforestry Specialist. She has been a wonderful addition, bringing a wealth of experience in reforestation and agroforestry.

The smallholder farmers have continued to nurture the 25,000 trees that have been planted on degraded land in Loreto and received management support and advice from our full time project technician. Overall we are seeing particularly good growth of the native timber species *Añallu caspi (Cordia ucayaliensis)*, *Marupa (Simarouba amara Aubl)*, *Tornillo (Cedrelinga catenaeformis Ducke)* as well as of the cocoa (*Theobroma cacao*). There has continued to be insect attacks, which have particularly impacted the timber species capirona and some of the lime trees. To deal with this farmers have been provided with and trained in the targeted application of insecticides.

The growth of the cocoa trees, which were part of the most recent 5,000 young trees planted in 2016, has been really impressive and the grafting has been very successful. The grafting has meant better cocoa yields and the production of aromatic varieties of cocoa with a better flavour and a higher value when sold for chocolate. Farmers are already able to reap good harvests and earn a better income from sale of cocoa beans, to support their families.

Our main funding has continued to come from UK trusts and foundations this year as well as from a grant within Peru from the Fund of the Americas. This year also saw our first attempt at Crowdfunding, through the Big Give Christmas Challenge, that took place between the 27th November and 4th December. The campaign is an innovative idea to encourage donations from the public with the promise that they will be doubled by match funding. We set an ambitious target of £10,000 but are very pleased to say that this was exceeded, with a final total of £11,474.50 raised during the week.

Plant Your Future underwent a brand transformation this year, thanks to the help of our wonderful probono team. A new logo and website were designed, and thanks to Adam Dickens of Taking Pictures, Changing Lives, we also have an entirely new catalogue of photos and videography, showcasing the best of the farmers we work, their families and the trees and crops they are growing with the support of PYF. The new website means that it is now accessible through mobile, and its transformation will continue over the coming year with many more planned features.
